# Agency seeks input on Medicaid waiver serving people with intellectual or developmental disabilities

BISMARCK, N.D. – Last state fiscal year, about 5,300 North Dakotans with intellectual or developmental disabilities lived in a home of their choice in a community setting because of in-home long-term supports and services funded through a state Medicaid waiver.

The 1915(c) Traditional Individuals with Intellectual Disabilities and Developmental Disabilities Home and Community-Based Services (HCBS) waiver expires March 31, 2019. The North Dakota Department of Human Services' Developmental Disabilities Division is seeking public input on waiver services as a first step in the waiver renewal application process. The agency is hosting public meetings between May 29 and June 4 in nine communities using the statewide videoconferencing system.

"We want to hear from people who use services, their family members and guardians, advocates, service providers and other partners," said Developmental Disabilities Division Director Tina Bay. "We really want to learn what people like about the waiver, as well as ideas on ways to improve it."

Bay described the waiver as a program authorized by federal law that provides federal matching funds for in-home and community-based services for individuals with intellectual disabilities who qualify for Medicaid and also meet level-of-care requirements.

Each of the nine meetings will follow the same agenda. Division staff will briefly review the current waiver, and then attendees will be able to share observations about the waiver.
