# **Early Childhood Division**

Child Care and COVID
Fall 2021 Program Updates

Since March 2020, child care programs operating in North Dakota have been working diligently to adhere to best practice health and safety guidelines, as per guidance from public health and early childhood health specialists. This has made it possible for families in communities across the state to have access to child care for their children.

Today, the reality of continued and increasing community transmission of COVID-19 requires that the child care sector maintain its vigilant posture. Because we are still operating in a time of pandemic -- a disease event that is widespread and affects a large number of people – child care programs are strongly encouraged to adhere not only to required practices, but also to follow guidance and best practice to minimize the risk of infections.

- **Follow** minimum **sanitation** and **safety requirements**<sup>1</sup> and your program's policies regarding exclusion and return<sup>2</sup> as per ND Administrative Code.
- Utilize enhanced health and safety guidelines and infection control procedures as outlined in CDC Guidance for Child Care settings, as well as guidance offered by the ND Department of Health.
- Be proactive! Open and honest communication will give each family the information they
  need to be able to make decisions as they need to for their own family.
  - Share information with parents about practices being followed in your setting.
  - Notify parents when there are active infections in your program, telling them of your decisions regarding exclusion and quarantine and the decisions you have made in response
- Practice the CDC's layered prevention strategies at your child care.
  - Experience has shown that continued commitment to using screening questions for people who enter the child care setting, especially when used along with <u>CDC's</u> recommended layered prevention strategies can shorten the duration of program closures, and often can help ensure that programs can avoid receiving advice to close altogether.

#### **Quarantine Procedures**

If a child care provider learns of a positive COVID-19 case in their program, they should:

- 1. Contact the ND Department of Health at <a href="mailto:dohcovidchildcare@nd.gov">dohcovidchildcare@nd.gov</a> or call the hotline at 1-866-207-2880.
- 2. Call your licensing specialist and report any need to quarantine or program closure due to COVID.
- 3. Notify affected families. Since DoH is NOT initiating contact tracing at this time, it is the provider's responsibility to contact their families to let them know of the exposure. ND DoH staff will provide a letter for providers to share with families.

The Department of Health has published a Q&A document specifically for child care providers, with a goal of explaining a variety of scenarios that providers and families may encounter.

## Coming Soon! New Child Care Program Grants Will Support Pandemic Operations

To help child care programs and workers continue to navigate the ups and downs of operating during a pandemic, DHS will be making a series of grants available, with more information to come by early September.

These grants are not competitive, which means if a child care program submits a complete application, is eligible, and agrees to abide by the grant program terms, they will receive funding, as long as there is funding available.

Applications will open on approximately September 20, 2021, and will be available through a new grant management module in the Growing Futures registry.
