Intake Matrix Business Rules:

When conducting intake, start at the lowest level possible and consider diverting multiple times prior to scheduling the first informal adjustment. Cases should have at least one prior diversion, if not two or three before being scheduled to come in for an informal adjustment.

- Any offense which requires a notification to be sent to the North Dakota Department of Transportation requires at least an informal adjustment as notice can only be sent to ND DOT after an "admission" is received.
- Any offense which could require sex offender registration should be staffed first with the county state's attorney and if they
 authorize an informal adjustment or charging at a lesser offense level, that decision should be obtained in writing or at least
 document in CMS contacts.
- Any offense which will require 24/7 Sobriety Program may result in supervised probation to assist the youth in complying with all the requirements.
- Juvenile Court staff should not recommend the filing of a transfer to adult court unless it is a mandatory transfer offense.
- Juvenile Court staff should not recommend an interim YCC evaluation as we use the YASI assessment in the community to determine risks and needs.
- Competency and / or Amenability to Treatment in the Juvenile Systems Evaluations are performed at the North Dakota State Hospital unless arranged with a private evaluator by defense counsel.
- Referrals received on a youth in residential placement but are from another region shall be staffed with the JCO III of the home
 jurisdiction prior to a formal petition being filed.

When developing a least restrictive disposition recommendation under the juvenile court mission of balanced and restorative justice, the assigned juvenile court officer will consider the following factors along with the Disposition Recommendation Matrix:

- 1. The best interests of the child;
- The results of the child's YASI full assessment including the youth's protective factors, static and dynamic risk factors and identified needs;
- 3. The referred offense(s) and any aggravating or mitigating circumstances;
- 4. The impact on the victim and any requested restitution or other wishes of the victim;
- 5. The risk to public safety the child poses;
- 6. The extent to which enhanced involvement and supervision of the child may improve public safety concerns;
- 7. Evidence of a repeated pattern of behavior by the child;
- 8. Any statutorily mandated dispositions (such as 24/7 program, notice to North Dakota Department of Transportation or transfer to adult court):
- 9. Whether the child meets criteria for Juvenile Drug Court where program is available.
- 10. The results of any court-ordered or filed with the court evaluations that indicate a need for out-of-home placement in order to access an appropriate level of treatment.

Reduced Level of Supervision and Early Termination / Modifications to Non- Treatment Conditions of Probation

Early termination from probation, modification in reporting requirements, letter in support of expungement, fine reduction, reduction in community service hours.

Interventions for Serious Behavior

(ex., school suspension, felony citation, sex offender with pornography, contact with victim, school suspension)

GPS, home detention, increased person restrictions, involvement in long-term programming, increased supervision, mandatory reporting to juvenile court, pick-up and hold, review hearing.

Earned Privileges

Driving privileges, overnights, extended curfew,phone visits, gifts.

Interventions for Moderate

(ex., curfew violation, missing appointment or class, positive drug screen, home/parent issues - ongoing, school infractions - ongoing, work absences)

Closed campus, no overnights, computer/cell phone restrictions, curfew restrictions, involvement in short-term programming, community service, driving restrictions, homebound, journal/booklet.

Positive Acknowledgement and Recognition for Progress

Recognition by the Judge through written letter of commendation, recognition by the JCO through written letter and commendation, certificates of achievement.

Interventions for Minor Behavior

(ex., curfew violation, missing appointment or class, positive drug screen, home/parent issues - isolated, school infractions - isolated, work absences)

Written assignment, apology letter, verbal admonishment, problem solving with youth, school conference, parent/child conference.

- * Short-term programming: Programming that constitutes three sessions or less.
- * Long-term programming: Programming that constitutes four or more sessions.
- * Programs from a lower level can be utilized in higher levels the same is not true in reverse.
